2.2 Description

The main objective of the of this project is to accelerate resettlement of internally displaced persons (IDPs) currently located in squatter settlements into their neighborhoods of origin or with host families or in new, economically viable settlements.

During the transition phase of this effort, transitional shelters are to be constructed to replace homes that were destroyed by the January 2010 earthquake. The main obstacles to constructing these shelters include the debris from destroyed homes and the presence of unsafe red homes.

In order to expedite construction of shelters/houses and facilitate the relocation of IDPs, this project will incorporate the use of heavy equipment and other means to augment other efforts in building demolition and debris removal.
